THE IDAHO RONALD MCDONALD HOUSE IS A 19 BEDROOM FACILITY THAT PROVIDED A TEMPORARY HOME AWAY FROM HOME FOR 543 FAMILIES WITH HOSPITALIZED CHILDREN IN 2014. FAMILIES CAME FROM ACROSS IDAHO, EASTERN OREGON AND NORTHERN NEVADA AND WERE ABLE TO STAY AT THE HOUSE DURING THEIR CHILD'S MEDICAL TREATMENT. FAMILIES ARE PROVIDED WITH SHELTER, FOOD ITEMS, SUPPORT AND CARE. THE AVERAGE LENGTH OF STAY WAS 9 DAYS AND OVER 80% OF THE FAMILIES THAT USE THE HOUSE PAY NOTHING OUT OF THEIR POCKET FOR THEIR STAY. THE REMAINDER PAY PART OF A NOMINAL \$10 PER DAY DONATION.
