THE IDAHO RONALD MCDONALD HOUSE IS A 19 BEDROOM FACILITY THAT PROVIDED A TEMPORARY HOME AWAY FROM HOME FOR 572 FAMILIES WITH HOSPITALIZED CHILDREN IN 2016. FAMILIES CAME FROM ACROSS IDAHO, EASTERN OREGON AND NORTHERN NEVADA AND WERE ABLE TO STAY AT THE HOUSE DURING THEIR CHILD'S MEDICAL TREATMENT. FAMILIES ARE PROVIDED WITH SHELTER, FOOD ITEMS, SUPPORT AND CARE. THE AVERAGE LENGTH OF STAY WAS 9 DAYS AND OVER 77% OF THE FAMILIES THAT USE THE HOUSE PAY NOTHING OUT OF THEIR POCKET FOR THEIR STAY. THE REMAINDER PAY PART OF A NOMINAL \$10 PER DAY DONATION.

FOOD BOX PROGRAM: SOME FAMILIES OF PEDIATRIC PATIENTS AT OUR PARTNER HOSPITALS STAY AT THEIR CHILD'S BEDSIDE. PERHAPS THERE ARE COMPLICATIONS THAT MAKE IT NECESSARY FOR THEM TO BE THERE AT ALL TIMES. THE RONALD MCDONALD HOUSE MAY BE FULL AND THEY ARE WAITING FOR AN AVAILABLE ROOM, OR THEY MAY LIVE CLOSE ENOUGH TO DRIVE HOME AT THE END OF EACH DAY. WE STILL PROVIDE CARE AND SUPPORT BY DELIVERING A FOOD BOX SO THE FAMILY HAS NOURISHING AND CONVENIENT SNACKS. FAMILIES WHO STAY AT THE HOUSE ARE OFFERED A FOOD BOX WHEN THEY CHECK OUT. THEY CAN SELECT ITEMS THEY NEED FROM THE GUEST PANTRY TO TAKE HOME. IN 2016 WE WERE ABLE TO ASSIST 87 FAMILIES IN THIS WAY, HELPING THEM TO REDUCE FINANCIAL BURDENS AND SPEND MORE TIME WITH THEIR CHILD.
